Friends World Committee for Consultation (FWCC) Section of the Americas has announced that the **Quaker Youth Pilgrimage** will be in the Pacific Northwest in the summer of 2010. Jointly sponsored by the Section of the Americas and FWCC's Europe and Middle East Section, the Quaker Youth Pilgrimage enables high-school age Friends, ages 16-18, to learn about Quaker history and process, develop a stronger relationship with God, and experience the diversity of Friends' traditions and worship while traveling, living, and working together for a month. Drawing youth from throughout North America and Europe, and occasionally elsewhere, the pilgrimage takes place once every two years in areas that vary from each instance to the next.

In 2010, Quaker youth will gather in Seattle on July 16th, travel in Washington State and Oregon, and then return to Seattle for departure on August 13th. (NOTE: The dates might be changed to July 18th-August 15th; a final decision is still pending.) The Quaker Youth Pilgrimage Committee, being clerked this time by former NPYM Friend Bill Schoder-Ehri, is

looking for a few Friends who can help with this Pilgrimage. Its first week will be spent at Quaker Cove near Anacortes, during which time the young Friends will be doing maintenance work as a service project while bonding as a community and learning from one another's experiences. During this week a visit to Bellingham Friends Meeting is a possibility, and there may be other ways in which Bellingham Friends can be helpful and welcoming.

More details about the Pilgrimage and how some of us might relate to it will be forthcoming in a future issue of <u>Metamorphosis</u>, as will information for any local youth who may wish to apply to participate in the 2010 Quaker Youth Pilgrimage.

Eco Suggestion of the month - Safety in using plastics in cooking

Heating plastics increases the chances of leaching chemicals from the plastic. One particular concern is a group of chemicals called phthalates which can act as endocrine hormone disruptors in humans and animals. These are added to some plastics to make them less brittle and they can leach into food if the plastic is heated. Here are some safety tips from the Johns Hopkins website.

- 1. When cooking with plastics or plastic utensils, use only plastics specifically meant for cooking. Heat resistant glass, ceramic and stainless steel are better. 2. Remove food from packaging before defrosting in microwave. Do not use foam or plastic wrap.
- 3. Only use cookware that is specially manufactured for use in the microwave oven. Glass, ceramic containers, and all plastics should be labeled for microwave oven use.
- 4. Microwave plastic wraps, wax paper, cooking bags, parchment paper, and white microwavesafe paper towels should be safe to use. Do not let plastic wrap touch foods during microwaving.

Book Review

Amish Grace: How Forgiveness Transcended Tragedy by Donald B. Kraybill, Steven M. Nolt and David L. WeaverZercher

Are there limits to forgiveness?

Early on a Monday in October of 2006, a man entered an Amish schoolhouse in Nickel Mines, Pennsylvania. Before the day was over, he had killed five girls and wounded five others. Athough he and his family were not Amish, the man was known to the Amish. He drove a milk truck and lived nearby. Before killing any of the girls, he called his wife and explained that his motive was retribution for the loss of a daughter, who a year earlier had died during the birth process. After shooting the girls, he killed himself.

School shootings have become an unfortunate fact of modern life, but the setting seemed unusual for such a tragic event. Amish farmland brings to mind a quiet way of life, in which people work with their hands, avoid modern technology and depend upon each other for support almost exclusively. The fact that it happened to people committed to peace made the shooting seem even more tragic.

The authors of this 237 page book are academics at nearby small colleges who have taken a scholarly approach to the Amish in the past. They became involved when the media began to hound them to explain the Amish reaction to the deaths of their children, which soon became a much larger story than the killings.

The news anchors could describe it, but they could not explain it. The Amish forgave the

killer. They visited his family and made clear that they, too, were victims in the eyes of Amish community. They went to the killer's funeral, where an elderly Amish man was overheard saying to several small boys, "We must not think evil of this man". Forgiveness of this degree was so incomprehensible that some members of the media later turned on the Amish and accused them of duplicity.

The bulk of this small book describes the origins and beliefs of the Amish. There are brief conversations with Amish folk (mostly men) who have known the authors for years. Other incidents of violence directed at Amish are described and discussed. What becomes clear is the Amish belief that to be forgiven, one must forgive. God cannot be expected to forgive those who do not forgive others.

While somewhat redundant, this book is quite readable. It is not academic in style. The authors, perhaps inspired by their subjects, treat them fairly. On Amazon.com, 46 readers rated this book 4.5 on 5 point scale, which is unusual near-unanimity of approval.

Our Meeting for Business began with opening silence.

Our History: Howard shared some history about "Three Ravens & Two Widows," written by Richard M. Kelly. The ravens are a metaphor for the conflict that existed between the Evangelical branch of Quakerism and the more traditional, liberal branch. Mr. Kelly's mother and grandmother disagreed in their beliefs of Quakerism, but they did not disagree on their love for their son/grandson. Whatever your disagreements may be, one can still practice love/acceptance and the basis of Quakerism: Listen to and practice the guidance that Spirit provides.

<u>Our Future</u>: There is the hope that our Meeting will become more loving, deepening our community and allowing us to learn more about who we are. In tune with our query this month, one hopes that all adults listed in our directory will become active participants in at least one committee. We hope to see our Meeting thrive so that infants like Annelisa will become role models just like our elders are.

Agenda Review / Approval: Adjustments were made and the agenda was approved.

Committee Reports:

Ministry & Counsel:

- 1. The query for this month from NPYM Faith & Practice, p.42-43: Do we each take an active part in the life of our Meeting? How do we recognize the varied skills and spiritual gifts of our members and attenders? How do we nurture their use and growth?
- 2. Care of Meeting guidelines have been rewritten, and we encourage Friends to undertake this pastoral responsibility, using their own words, guided by the Spirit. A member of M & C will be assigned for each Sunday in case no one else signs up.
- 3. The welcome brochure continues to be a work in progress, but we have made some copies of the old one to serve until the new one is ready.
- 4. In lieu of a telephone tree, in cases where news needs to be disseminated among Friends quickly, please call a member of M & C.
- 5. Background checks for those working on a regular basis with our children have been cleared through the Washington State Patrol. There is some concern, however, about adults who are not members or regular attenders of our Meeting and who have been with the children recently. We feel the need of a specific policy here.
- 6. (Decision item) A letter has been received from Bob Schultz, our speaker of last week, asking that we make our directory available for either a) three copies of the Washington Newsletter followed by a letter; b) a one time mailing; or c) two email messages. FCNL will never share names or addresses with any other organization. M & C recommends that we provide email addresses for two messages. We also recommend that we revisit the decision made in January 2008 in regard to a similar request from Right Sharing of World Resources, whereby Friends had to request to be put on a list for a one-time mailing. These are Friends' organizations doing Friends' work on our behalf. Should we deny them the opportunity to acquaint us with the work they are doing for us? Friends approved the third option, above, with the intent to provide our email list rather than our directory. The issue regarding a similar request for Right Sharing of World Resources will be brought forth at next month's business meeting by P & SC.

Peace & Social Concerns:

P & SC discussed how to apply the information provided in Bob Schultz's workshop in general and for the committee's letter of the month specifically. Use of websites such as FCNL and their timely letters on Potluck Sunday was suggested. By using these letters, Friends could

personalize them and send them directly and easily during potluck. The need for readily available computers and the use of Exploration's computers (which are in the room) were considered.

After talking with Daniel on this matter, a better option would be to use the school's high-speed Internet connection with several personal laptops brought by Friends. Use of Exploration's computer was fraught with complications unnecessary to take on at this time. (A discussion followed, and it was suggested that P & SC could also e-email a letter for Friends to forward from their homes.

P & SC also discussed letters to the editor as a tool to promote earmarked social causes. It is necessary to involve more Friends other than just committee members since the Herald does not print one individual's letters repeatedly. (It was suggested that the Herald might publish an organization's letters once per month. Is there an interest here? P & SC will pursue this matter.)

Nominating Committee:

There are no changes in the finance committee job description since last year. Unsure whether this description was seasoned last year, **finance committee's job description and the newsletter job description have both been accepted for seasoning.** Any other committee job descriptions are welcome.

Earthcare:

FEC committee sponsored a birding expedition to Lummi Island on May 23rd, led by John Horner. Twelve people went and spent several hours walking, listening and looking for birds. We had great weather, and everyone enjoyed it. We hope to plan more such trips.

FEC committee plans to write a monthly petition on an environmental topic and bring it to Meeting for signatures.

FCNL:

Dear Friends: Since our FCNL rep, Tom Hall, is out of town, I thought maybe it would be okay if I made a brief report from a letter that was forwarded to me from FCNL, especially in light of Bob Schultz' recent visit. A report from Ruth Flower to Joe Volk points out how the reality in Washington, DC has changed. For example, FCNL staff has helped to shape key sections of the Foreign Relations Authorization Act (H.R.2410), which will set up critical changes in U.S. relations with the rest of the world. The bill has sections, which focus on diplomacy used to prevent war and genocide.

Jim Fine persuaded the House to insert language into the war supplemental bill to prevent building permanent military bases in Afghanistan. FCNL is also excited that there were 60 votes against the war supplemental, when they had anticipated maybe 10!

Devin Helfrich has been working in coalition with other groups on building support for a carbon tax. Although no such bill is expected to pass this year, the members of Congress in support of a carbon tax is growing.
