# Bellingham Friends Meeting <br> MfWfB April 10, 2016 <br> Approved Minutes

Meeting opened after silent worship at 12:07. Virgina H read a passage from George Fox.
2016.04.1 Minutes of the March business meeting were approved as amended. 2016.04.2 Ministry and Counsel Report (Attached)
2016.04.2.1 Guidelines for Committees in Decision Making - document was read

- A Friend asked for confirmation that this document was a restatement of what we already do or should be doing.
- Virginia responded yes, and explained further that it was meant to help people understand.
- Another Friend said it would help avoid mistakes
- A Friend asked to add a phrase at the end of item 3 -"particularly for those concerns not appropriate for any specific committee"
- Another Friend had 5 concerns:

1. point \#6 spelling correction-made
2. 1st footnote regarding the official name of the meeting. This Friend thought it was not accurate (never having seen any document with that name before) and seemed pompous. Another Friend liked it. Another Friend expressed appreciation for the historical reference.
3. A decision was made to allow the editor to change the footnote to include reference to historical changes in the meaning of "Religious Society of Friends".
4. A couple of asterisks were in the wrong place
5. This Friend asked that committees be allowed to form ad hoc subcommittees but not standing subcommittees without approval from MfWfB
6. Clarification of "non-substantial" action- Friend suggested that if any member of the committee felt an action decision was "substantial", then it should go to MfWfB.
7. One friend had some concern about allowing committees to decide what is not "substantial".
8. Another Friend felt that it was a good idea to allow committee members to weigh in on what goes into the report, and that any committee member could add any item to the report.

- Another Friend asked at what threshold does a budget item become "substantial" in MfWfB and therefore require seasoning.
- Two Friends expressed a concern that all Friends should be welcome to speak to any item in a committee report at MfWfB, and that this should be included in these guidelines.
- Another Friend expressed a concern that committees can go "rogue", and that there should be some system for "eldering" for committees. A Friend mentioned that Faith and Practice gives members of the meeting oversight function, and that this oversight is exercised at MfWfB.
- A Friend asked that there be structure provided about giving committee reports and that it include solicitation of comments and questions. Virginia H. will add this. Another Friend suggested that this guidance be combined with the earlier request that all Friends be welcome to comment on any item in a committee report.
- This guideline will be revised in accord with the suggestions offered.
2016.04.2.2 Meeting's Annual Retreat - M\&C recommended we have our spring retreat in June, and asked whether anyone would be willing to work on planning a retreat in June.
- Sharon, Virginia, and Joanne volunteered to be on this committee
- A Friend asked that the question addressed be visioning the rationale for a new meetinghouse rather than details of a space.
- Friends generally supported that idea. A suggestion was made that the committee might ask for feedback during their planning process via posts in the e-news.


### 2016.04.2.03 The State of Society Report was approved.

2016.04.02.04 - comments on remaining items in the M\&C Report. Other than requests for clarification, joy was expressed regarding Kristen McLewin's letter requesting membership in the meeting.

## Report from Outreach and Welcoming Group to Bellingham Friends Meeting MfWfB, April 10, 2016

The Outreach and Welcoming Group would like to report on two actions:

1. At our last meeting on March $19^{\text {th }}$, we discussed the "all are welcome here" poster that had been brought to MfWfB on March $13^{\text {th }}$ and referred to us for discernment. Since our outdoor sign already makes it clear that all are welcome to attend and/or join our Meeting, we felt that further action really fell more within the jurisdiction of the Social and Environmental Concerns Committee and we have therefore referred the matter back to that committee.
2. In January we were asked for discernment concerning the possibility of a large wall-mounted display for nametags and photographs of Meeting members and attenders. We discussed this matter in February and decided that there were too many logistical difficulties involved in maintaining such a display that it would be impractical even if Explorations Academy were willing to leave it more or less permanently mounted (and considerably more so if they were not willing). With input from John Hatten we discerned that a more practical way of making photos of Friends available to those joining us, whether newcomers or not, would be to have an online photo gallery posted on our website. Anyone could, of course, opt out of having their photo included. We are currently working on the logistics of creating such an online photo gallery.

Related action item: The online photo gallery could be posted in either the public or the private portion of the website. We recommend the public portion, since a major purpose of having the gallery is to help introduce newcomers to us visually as well as by name. However, some Friends may have privacy concerns and for that reason advocate for the gallery to be within the password-protected portion of the site. However, if the gallery is public any such Friends can always opt out of being included, or may opt to just have their names and not photos included.
