<u>Discussion</u>: A discussion ensued regarding who should receive copies of this document. Several suggestions were offered. John Hatten suggested it be sent to NPYM and to any group that SEC thinks could receive. Others suggested Western Friend in addition.

2016.09.02.2 Action item: Would the meeting approve use of the Quaker banner at the Sept 12 rally for the Standing Rock Sioux? **The meeting supported use of the banner. 2016.09.02.3 Information item**: Joan reported that in the absence of a regular clerk, clerking duties will be rotated monthly among committee members.

2016.09.03 Ministry and Counsel- Susan R (report attached)

2016.09.03.1 Action item: The Meeting approved the membership of Kristen McLewin.

2016.09.03.2 Announcements:

- · Ministry and Council will have a committee retreat in October
- Retreat Follow-up report is included in the M&C report
- M&C will arrange a series of second hours on Friends desires for a meeting house

<u>Discussion</u>: Questions were raised about the purpose of this series and whether we should have the meeting house scouts continue to look for a place. Sharon T noted that many Friends are informally looking for a suitable place.

A question was raised regarding reports of potential spaces since the Meeting previously agreed that potential sites examined would be brought to the attention of the meeting. Sharon T noted that and agreed to inform the meeting of sites evaluated to the extent that she was aware of them. Judy H shared that she and her husband had explored a place that looked perfect, but was unacceptable because of the long-time residence and consequent saturation with the odor of multiple cats.

2016.09.04.1 Action item - OWC asked that the meeting have a formal policy that pictures of children not be included in the online photo gallery for safety concerns.

Discussion: Upon questioning, it was clarified that this policy would not apply to group pictures, but only the gallery. Karen S asked whether there are safety concerns or documented safety risks associated with children's photos online. Other Friends asked about the reason for the proposed policy. Don G responded that a few adults have declined to have their picture on the internet, and the committee felt that it should therefore be careful about children's pictures. Sharon T expressed frustration that Friends were not allowing the committee to do its work. John H handed his clerking role over to Susan R in so that he could express his own feelings that all pictures should be a personal choice. He felt that pictures of children to be a personal choice of the children's parents. Dusty A pointed out that our meeting has a private and a public section. She and Joanne Cowan suggested putting the pictures in the private section. John H suggested that there is an easy way to put the pictures of children in a private section. A suggestion was offered that a request for comments regarding posting of pictures of children be placed in the E-News. After being asked for her input as the parent of a young child, Lisa F shared that other groups to which she belonged avoided posting names of children and posted only group pictures without names to illustrate that the group did include children. She also noted that other groups obtain and archive permission from adults, and she hoped our meeting would do so as well.

Minute of the Bellingham Friends Meeting of the Religious Society of Friends (Quakers)

Approved by the Social and Environmental Concerns Committee of BFM on September 8, 2016, submitted to Meeting on September 11, 2016.

Approved: by Bellingham Friends Meeting on ______.

Our Meeting strongly supports the Standing Rock Sioux in opposing construction of the Dakota Access Pipeline, and in insisting that their legal and treaty rights be fully honored and not be violated.

This 1100-mile pipeline would create the same dangers as other projects, such as the Keystone XL Pipeline, and should be rejected for the same reasons. The Dakota Access Pipeline proposal process absolutely warrants thorough and intensive environmental consideration, and full engagement with the Standing Rock Sioux, whose rights <u>must</u> be respected. These include but are not limited to the right of access to clean water, which is the foundation for all life, as well as the right to have their burial grounds and other sacred sites respected, protected, and preserved.

The word, "Dakota," means "friend." As Friends (Quakers), we bear witness to the equality and sacred nature of every person. The principle of equality is also fundamental in a democratic society. When we as a society shut out the voices and ignore the rights of Native Americans as in the current situation, we deny that principle.

As Friends, we also hold sacred the responsibility of all humanity to care for the Earth, our home, and preserve it for future generations and all life. Our Native American sisters and brothers have long modeled the importance of considering not only our own desires, but also the needs of future generations, <u>before</u> acting. Expediting projects such as the Dakota Access Pipeline, and pursuing the extraction, transport, and use of fossil fuel instead of renewable and sustainable alternatives imperils the earth's waters, the atmosphere, the air we breathe, and the climate necessary for continued life on earth, all of which are vital to the Standing Rock Sioux and to all life. If we are to act quickly at this time, let it be toward developing and implementing environmentally sound practices to preserve our Earth-home and all life on it.

Children's Program Committee Report Bellingham MfWfB Sept. 11, 2016

1. Attendance: We have had very regular attendance over the summer, including two new families and a dozen children attending the campout at Excelsior Campground!

a. Snack policy. Because we have several children who are gluten intolerant and one who is celiac, we will be only offering the kids wheat-free, gluten-free snacks during announcements. Parents will be responsible for monitoring children's access to regular snack that is shared with everyone, but we felt it would be better for all the kids to be respectful of the dietary needs of all. There are some tins of cookies above the admin cabinet that the children sometimes ask for. We agreed to label those "adult snack" and ask Friends not to give wheat cookies to kids during announcement time, but instead use those treats up during the adult coffee/snack time. **b.** Age range. The ages of our kids range from 2 to 19 at present. As a general rule, we recommend that teachers plan with older children in mind (we have five who are 10-13), and simplify the lesson if only younger children attend. If there is a full range of ages present, we recommend that after the initial circle time, the childcare worker will take the younger kids aside for drawing or a simple story, while the volunteer teacher continues the lesson/discussion with the older kids. Please check in with CP committee members if you have experiences with this issue: what works? What doesn't?

2. Upcoming schedule:

- **3.** Lesson plans available: We have two *Friends Through Time* curriculum lessons posted on the website for anyone who would like to use them. There is also curriculum available in the Children's Program library, which is in boxes in the CP cabinet in the Commons.
- 4. Living Our Testimonies Project: Children's Program Committee is developing an "umbrella" project that will enable young Friends (8 and up), if they choose to participate, to build their understanding of and experience with Quaker testimonies. It will also allow the Meeting to recognize and celebrate their growing fluency. The basic idea is that each child can have a looseleaf notebook in which they can assemble a record of their experience with Quaker testimonies lessons, experiences at Meeting and outside of Meeting that they share with the other kids, and records of the historical roots of each one. When they reach certain landmarks, they will be recognized by the Meeting and can celebrate their achievements. We are working on developing more details, and look forward to sharing them with you soon.
